

GENERAL RELEASE AND WAIVER OF LIABILITY
Spring 2020 HOT SHOTS SOCCER CLASSES

I, (child's name) _____ (the "Participant"), and if such Participant is under 18 years of age, then also the parent or legal guardian of such individual (together with the Participant, the "Undersigned"), sign this release and waiver of liability (this "Release and Waiver") in consideration of participating in the soccer activities at the Fall 2020 classes beginning on March 16th at various parks in Tomball and College Station, TX (the "Soccer Events"). The Undersigned hereby releases and discharges Hot Shots Soccer (the "Company"), and its respective assignees, successors, officers, directors, agents, representatives, employees, sub-contractors, sponsors, shareholders, partners, members and affiliates (the foregoing collectively, the "Released Persons") from all present and future liabilities, debts, obligations, costs, expenses, damages, losses, charges, judgments, executions, liens, claims, demands, actions or causes of action of whatever nature or description, in equity or at law, which the Undersigned or his/ her child or ward, family, estate, heirs, representatives, executors, administrators, successors or assigns (collectively, "Related Parties") may have, whether known or unknown, suspected or unsuspected, asserted or not asserted, arising out of participation by the Undersigned or his/her child or ward in the Soccer Events.

The Undersigned understands, acknowledges and accepts that this Release and Waiver is intended to be binding on the Undersigned and the Undersigned's Related Parties. The Undersigned further understands, acknowledges and accepts that participation in the Soccer Events involves certain inherent risks, including, but not limited to, property damage and serious bodily injury (including death), and agrees that the Undersigned or his/her child or ward is voluntarily participating in the Soccer Events with full knowledge of the risks involved and accepts all risks of participation. The Undersigned declares that the Participant is physically fit and has the requisite skill level to participate in the Soccer Events. The Undersigned authorizes the Company and/or a party designated by the Company to provide medical treatment to the Participant, at the Undersigned's cost, should the need arise. The undersigned understands, acknowledges and accepts that he or she must provide his or her own medical insurance for the Participant.

Furthermore, the Undersigned grants to the Released Persons the perpetual, transferable, sublicenseable, worldwide right free of charge to use the Participant's image, likeness, name, face, appearance or voice (the "Participant's Image") in whole or in part via any media and for any purpose without reservation or limitation in connection with any broadcast, photograph, publicity, advertising, exhibition or promotional materials. The foregoing grant of rights does not impose any obligation upon any Released Persons to use the Participant's Image in any manner.

The Undersigned understands, acknowledges and accepts that this Release and Waiver of Liability is intended to be as broad and inclusive as permitted by the laws of the state in which the Soccer Events are taking place and agrees that if any portion of this Release and Waiver of Liability is invalid, the remainder will continue in full legal force and effect. The Undersigned further agrees that any legal proceedings related to this Release and Waiver of Liability shall take place in Texas.
